



## **Product Change Notice**

**Issue Date: 30 Nov 2005**

### **Change Type:**

Product Marking, package labeling and shipping documentation change – Change from Agilent Technologies’ branding and logo to Avago Technologies branding and/or logo.

### **Parts Affected:**

All products from Agilent Technologies Semiconductor Products Group.

### **Description and Extent of Change:**

Agilent announced an agreement to divest its Semiconductor Products segment to Kohlberg Kravis Roberts & Co. (KKR) and Silver Lake Partners. From 1 Dec 2005, SPG will become Avago Technologies Pte. Limited. In alignment with the Manufacturing Trademark License Agreement between Agilent Technologies, Inc. and KRR & Silver Lake, the following changes will be made.

#### **(1) Product Markings**

From 1 Dec 2005 to 28 February 2006

- No change to product markings currently with Agilent’s branding and/or logo.

From 1 March 2006 to 31 August 2007 (running change)

- Products markings will have either Agilent’s or Avago Technologies’ branding and/or logo.

From 1 September 2007

- All product markings will only have Avago Technologies’ branding and/or logo.
- The completion of the change over to Avago Technologies’ branding and/or logo may be earlier than 1 September 2007

#### **(2) Package Labeling**

From 1 Dec 2005 to 31 August 2006 (running change)

- Package labeling will have either Agilent’s or Avago Technologies’ branding and/or logo.

From 1 September 2006

- All package labeling will only have Avago Technologies’ branding and/or logo.

#### **(3) Shipping Documentation**

From 1 Dec 2005 onwards

- All shipping documentation will have Avago Technologies’ name instead of Agilent’s name.

### **Reasons for Change:**

Agilent announced an agreement to divest its Semiconductor Products segment to Kohlberg Kravis Roberts & Co. (KKR) and Silver Lake Partners on 15 August 2005. With this divestiture, SPG will become Avago Technologies Pte. Limited, from 1 Dec 2005 and will therefore proceed with the process of renaming and re-branding all our products, packaging and any other related documents or publications that our customer may receive.

**Effect of Change on Fit, Form, Function, Quality, or Reliability:**

There will be no impact on our products specifications or performance. The change will be on our physical product markings, package labeling and shipping documentation. The details of Avago Technologies branding and logo will be made available if requested.

**Effective Date of Change:**

As listed above.
